



TCMS MoC Requirements



Under Order 34, Maintenance of Competence is required for what?

It's not just for PC holders!!

- All appointments / authorisations / skills / competencies at the coal operation
 - Clause 11.1
- All persons nominated (Appointed) to perform Statutory Functions (WHS(MPS) Reg. Sch. 10 Statutory functions), not just those requiring a Practising Certificate
 - Clause 11.2
- All persons nominated (Appointed) to perform Statutory Functions that require a Practising Certificate
 - Clause 11.3
- Workplace trainer/assessors
 - Clause 11.4

4.8.5 Training and assessment process for the safety role for workers

- Acme Coal Company will provide appropriate training and/or tools to workers to enable them to undertake the safety role described in cl. 120 of the WHS(MPS) Reg. This will include:
 - 1. basic information provided to all workers about how they are expected to perform their safety role. This content is included in induction training and addresses how workers, or their representatives may be involved in the identification of principal hazards, the consideration of control measures for risks associated with principal hazards, the consideration of control measures for risks to be managed under principal control plans, and/or the conduct of a review of SMS documents, and
 - 2. additional information, training and instruction provided to workers participating in high level risk assessments e.g., training / competency as a participant in risk assessments, and
 - 3. additional information, training and instruction provided to workers participating in reviews of SMS documents.


